### **Approve Minutes**

### Minutes from June 3, 2020 Regular Meeting

Mr. Jones noted a few typos, and no substantive changes. Mr. Jones moved to Approve the minutes for June 3, 2020 as amended. Second by Ms. Tanza. **All in Favor.** 

### **New Business**

### 6 Papoose Lane Situation

Ms. Maggio began the discussion by recapping the recent dog activity at the residence. On June 6, five dogs were seized with the cooperation of the State Police, Windham County Humane Society and Game Warden. Two of those dogs were subsequently surrendered to the Humane Society, and the remaining five are in the process of being licensed. License fees were paid to the Humane Society, who will reimburse the Town. The fines and penalties owed to the Town have been handed over to a collection agency. It was also noted that the owner of the five dogs has indicated they will be sent south for bear hunting on June 18. There was further discussion about the situation with the residents, the responsibility of the property owner/landlord, and the concerns of the neighbors. There was consensus that the situation has seemed to stabilize and currently there is nothing more the Town can do, but the situation will continue to be monitored. The Board thanked Ms. Maggio for her efforts, along with Ms. Libby, the staff at the Humane Society, Vermont State Police and the Game Warden.

#### **Road Projects**

Mr. Bills and Mr. Clark have prepared a prioritized list of projects, and there was discussion of several of those. First on the list is the paving of portions of Hill Road, which had previously been tabled due to concerns related to the pandemic. After discussion it was agreed that preparing an RFP for paving and grinding those sections would now be prudent. Approving the RFPs will be placed on the agenda for the next meeting. There was also agreement to move ahead on several other projects, including tree removal and culvert replacement. It was agreed by consensus that Mr. Bills' plan to rent a wheeled excavator for one month at a cost of approximately \$6,000 makes sense, as it will enable the culvert replacement as well as other projects during that period. More projects will be discussed at the next meeting. The Board thanked Mr. Bills and Mr. Clark for their attention to all these projects.

### **Old Business**

### Tax Collection Update

Mr. Tanza reported that there is currently \$17,500 in outstanding tax liabilities for the 2019-2020 fiscal year. That is down from over \$40,000 that was initially outstanding. The Board thanked Mr. Tanza for his on going efforts on behalf of the Town.

#### SLP Update

Mr. Mello noted that Norm Holden had expressed to him that not all of the labor costs involved in the window painting had been factored into his bid last Fall. After discussion, there was consensus on the Board that Mr. Holden is expected to stand by the bid he made and that the Town had accepted. Mr. Mello also noted that he and Mr. Jones still have to discuss the woodchip/playground equipment situation with the tenants.
